Declarations of Interest

There were no declarations of interest.

1. Closed Session

The Council met in closed session with reference to the annual Board Self-Assessment Evaluation, returned directly to the Acting Chairperson, and on general Governance matters.

2. Admin/Financial

• Declarations of interest:

- The Council **approved the minutes** of the meeting of the Council held on 27th and 28th March 2024. Alessandro proposed and Adele seconded them.
- Matters arising

An update was provided in respect of the State Boards PAS process regarding the imminent appointment of a new Council Member. The separate advertisement regarding the Chairperson position is awaited.

April 2024, as set out in letters of appointment (and approvals set by Department of Public Expenditure and Reform), were reviewed and approved.

The Council reviewed and approved the draft **Annual Report 2023** for submission to the C&AG at audit stage.

Audit and Risk Committee Minutes

Adele, Chairperson of the A&RC, reported on the meetings held on 2 April and 5 May 2024.

- Reviewed and recommend to the Council the Management Accounts for Q1 2024, which were reviewed and approved by the Council.
- Reviewed and recommend to the Council the 2024
 Budget review, updated to reflect the payroll adjustments, as per government circular(s) and revised sanction in respect of the Council chairperson fee was reviewed by the A&RC and is recommended to the Council. The Council reviewed and approved the revised 2024 Budget.
- Mazars attended the A&RC meeting on 2 April. The report on the Systems of Internal Financial Controls (SIFC) 2023 audit, undertaken in January & February 2024, gives a reasonable level of assurance with one medium level finding and four low level findings.

A finalised draft of the report on the internal audit in respect of HR, undertaken in 2023, gives a reasonable level of assurance with two medium level findings and four low level findings, all of which have satisfactorily been addressed.

 The A&RC reviewed a presentation on the outcome, assurance levels and recommendation definitions of both the Internal and External audits conducted since establishment. There was a discussion on supports, to enhance the current routine evaluation control mechanisms of policies and procedures, to assist in a more comprehensive review in preparation for audit(s) to include utilising an external source to ensure that these remain compliant and effective, identifying areas of improvement and ensure compliance with current laws and regulations.

 The A&RC reviewed the Governance Handbook and four policies which are recommended to the Council and were agreed and actioned by the Council as follows:

Governance Handbook – the Council reviewed and agreed with the proposed updates.

Process for Setting Strategy - the Council reviewed and agreed the unchanged policy;

Learning and Development Policy - the Council reviewed and agreed the unchanged policy;

Gifts and Hospitality Policy - the Council reviewed and agreed some minor updates to the policy;

Recruitment Policy and Procedures – the Council reviewed and agreed the updates to the policy, revised to provide clarity in respect of the in person or remote interview process.

 The A&RC reviewed and discussed Section 2 (Staff and Resources) of the Risk Register and recommend continuing the changes to the format of the Register to clearly distinguish between current Controls & mitigating actions and proposed new policies or mitigating Actions. It is recommended that the language be strengthened in 2.1, 2.2, 2.3 and 2.4 of the proposed actions to reflect actual practice, in addition to increasing the likelihood in 2.1 size of secretariat and 2.4 workplans.

- Annual review of the effectiveness of internal controls

The Council is satisfied with the effectiveness of controls for 2023, having reviewed:-

(i) the draft unaudited Financial Statements including the Governance Statement and the Statement on Internal Control;

(ii) the minutes of all meetings of the Audit & Risk Committee;
(iii) the internal and external audit reports, progress on implementation of recommendations and the reasonable assurance in respect of the Statement of Internal Financial Control;

(iv) the risk register at each meeting;

(vi) the 2023 annual Board Self-Assessment Evaluation Questionnaires; and

(vii) agreed the 2023 draft Annual Report.
